



Introduction

In October 2018, Hurricane Michael caused widespread devastation in southwest Georgia destroying homes, businesses, and city infrastructure - including thriving community trees. To help restore the many environmental, economic, and social health benefits that trees provided in these storm-struck Georgia communities, the Georgia Forestry Commission (GFC) and the Georgia Tree Council (GTC), working in partnership with the U.S. Forest Service, are offering a special edition of the Georgia ReLeaf Program. Through this program, we will work with eligible communities and organizations in southwest Georgia to restore community tree canopy impacted by Hurricane Michael by providing free trees for residents to plant around their homes.

Program Objectives

The objectives of the **Southwest Georgia ReLeaf Program** are to:

- 1) Reestablish and improve the tree canopy in southwest Georgia communities
- 2) Restore the environmental, economic, and social health benefits provided by trees in these communities.
- 3) Provide tree care education and training
- 4) Help sustain health and diversity in Georgia's urban forests

Program Overview

Communities and organizations in southwest Georgia are encouraged to plan and host tree distribution events at which homeowners and residents will be given small containerized trees to plant in their yards. GFC and GTC will provide the trees at no cost. The trees will be in 5 gallon containers and consist of a variety of species and sizes at maturity (over-story, mid-story, and understory). GFC will provide educational materials such as flyers detailing species information, links to instructional planting videos, and other tree care information that can be provided to homeowners and residents.

Eligible Organizations

Non-profit organizations, units of local government (city, town, county), or educational institutions located in the following southwest Georgia counties:

Project Timeframe

- Application must be e-mailed to marylynne@gatreecouncil.org by **August 6, 2021**.
- Recipients will be notified by August 31, 2021. Approved projects can begin only
 after agreements are signed by the project organizer and the Georgia Tree Council.
- Events must occur between October 15, 2021 and February 27, 2022. (Georgia's Arbor Day will be February 18, 2022)

Project Specifics

- Applicant organizations plan a tree distribution/giveaway event and submit an application providing details of the proposed event such as:
 - a) Event date Indicate the preferred date and an alternative.
 The event must occur between October 15, 2021 and February 27, 2022.
 - b) Event time Indicate the start and end time of the event
 - c) Event location Indicate the proposed site/address of the event. If the event will take place at multiple locations, please list all locations.
 - d) Project Partners List any partner organizations involved in the project.
 - e) Marketing/Social Media Describe how the event will be publicized. Include any information about how participants will be selected (i.e. pre-registration, proof of residency, first come first served, etc.)
 - f) Tree Request Total number of trees requested from GFC/GTC. How many trees do you propose to distribute? Indicate the approximate number of each type/size/species of tree requested. Species may vary based on availability.
 - g) Event plan Describe the overall plan for the event including items such as pre-event tree care, staffing, and distribution of trees and educational materials.
 - h) Liability waiver submit a completed, signed liability waiver.
- GFC/GTC will work with organizers of approved projects to finalize details including determining the total number and species of trees provided by GFC, arranging for delivery or pickup of the trees, and obtaining educational materials produced by GFC.
